Membership Descriptions

Full Membership: Includes applicant, spouse and children ages 18 and under where the older spouse or single parent is age 36 or over. Also includes children ages 19 to 23 who are full-time students and/or living at home. Full membership includes use of the restaurant, golf, tennis, swimming, fitness area and Club events for all family members. Monthly Food Minimum applies.

Single Membership: Includes single individual only. Single memberships include use of the restaurant, golf, tennis, swimming, fitness area and Club events for single individual. Monthly Food Minimum applies.

Junior Membership: Includes applicant, spouse and children 18 and under where the older spouse is 35 or under. Junior memberships include use of the restaurant, golf, tennis, swimming, fitness area and Club events for all family members. Monthly Food Minimum applies.

Associate Membership: Includes applicant, spouse and children 18 and under where the older spouse is 32 or under. Membership includes use of the restaurant, golf, tennis, swimming, fitness area and Club events for all family members. Monthly Food Minimum applies.

Social Members: Includes the exclusive use of the restaurant only for individuals listed on the membership application. No monthly food minimum for social memberships.
